CITIZEN OF THE YEAR & LIFETIME ACHIEVEMENT AWARD

Each year the Juneau Chamber of Commerce acknowledges an individual who, through extra time and effort, has made an extraordinary commitment to the community of Juneau. The individuals who receive this award are identified by others within the community who take the time to nominate them and provide a summary of the individual's achievements. The Chamber hopes that you will take the time to nominate someone deserving of the award.

CITIZEN OF THE YEAR CRITERIA

- Nominee(s) shall be a citizen of Juneau that has personally contributed, by his/her efforts, to the welfare and reputation of the community
- Nominee(s) may be, but need not be, active in private industry
- Nominee(s) may be, but need not be, a member of the Juneau Chamber of Commerce
- Nominee(s) contributions to the community include a significant element of service outside of the source of his or her livelihood
- The focus will be on service in 2016 and 2017 but previous years of service to the community will certainly be considered.

The Citizen of the Year recognition is only awarded once to an individual.

The Citizen of the Year will be announced during the Chamber's Annual Dinner on October 14, 2017 at Centennial Hall.

LIFETIME ACHIEVEMENT AWARD

The same criteria guidelines, listed above will be considered, with emphasis on the contributions to our community over a significant period of time (10+ years.) (This award may or may not be granted each year depending on the applications submitted at the sole discretion of the Citizen of the Year Committee).

Prior Citizens of the Year are eligible for this nomination.

Please address each of the 5 criterion responses. Omission of information will be regarded as having no qualification under the particular criteria.

1. Personal contributions to the welfare and reputation of the Juneau community. If you can, include supporting news articles about the nominee and/or letters of support from other people that share your views. Greatest emphasis should be placed on contributions for the calendar years 2016 through 2017. *Significance Factor 8.*

2. Personal contributions to the welfare and reputation of the Juneau community prior to 2017. Again, include supporting news articles about the nominee and/or letters of support from other people that share your views. *Significance Factor 6.*

3. Community service activities outside of the source of his or her livelihood. Active participation in non-profit/service organizations should be emphasized. Passive memberships may be listed if noted accordingly. *Significance Factor 5.*

4. Community service to the business community within your livelihood. (These are activities that involve your profession, are job related, or otherwise related to the source of your livelihood. An example would be if you are a Doctor, but serve on a local medical board). *Significance Factor 4.*

5. Member of the Juneau Chamber of Commerce. *Significance factor 2.*
